TUNGSTEN IS THE ADVANCED LEAGUE, NICKEL THE INTERMEDIATE LEAGUE, AND BRASS THE BEGINNER'S LEAGUE, ALL PLAYING ON TUESDAYS AT 8 PM. A MINIMUM OF (4) PLAYERS OR A MAXIMUM OF (8) PLAYERS IS REQUIRED .
